**Board Resignations & Recognition**

**Lodging Tax Report** 

Clermont CVB Treasurer Randy Carter presented the lodging tax report. General discussion regarding the collection, distribution, and disbursement process followed. Reasons for monthly highs and lows were explained and justified due to tornado consequences (March) and the normal seasonality of travel and room occupancies during spring and summer months. Motion to approve the report was made by board member Barbara Wiedenbein. Second was provided by board member Don Ackermann. Motion was approved by all.

#### **Event Funding Requests**

June Creager- Mason presented two current requests pending before the Clermont CVB.

- Friends of Eastfork / Halloween Camp Out in the amount of \$500
- Felicity Businessman's Car Show in the amount of \$500

Mrs. Creager-Mason indicated that these are standard and typical requests for assistance by community event organizers that look to the Clermont CVB for various types of assistance from financial, to volunteers, to signage, food & beverage, and other types of advertising, promotion, and marketing support. Historically the Clermont CVB has provided this sort of modest level assistance and support. Motion to approve these expenditures to assist these community events was made by board member Jodi Inabnitt. A second was provided by board member Randy Carter. Motion was approved with no dissenting votes.

### **Executive Session**

Chairperson Jodi Inabnitt then asked that there be a motion to go into executive session for the purpose of discussion regarding personnel matters. Motion to move into Executive Session was made by board member David Uible and seconded by board member Andy Kuchta. All members voted affirmatively.

Board member David Uible made a motion to appointment Chris Smith as Interim Executive Director of the Clermont County Convention & Visitors Bureau. Board member Chuck Tilbury seconded, Smith abstained from vote, motion passed.
