Clermont Sports Development Corp:

<u>Balance Sheet</u>, Cash went from \$28,458.11 down to \$24,997.63 net decrease of \$3,460.48. Due to cash spent on Jon Boats and the net loss showing on the Profit & Loss statement.

<u>P&L</u>= insurance in the amount of \$198.00, Internet Connectivity expense of \$283.44. We should see our new price of \$98 kick in next month. Boat House Security in the amount of \$113.94.

#### **Clermont County CVB:**

<u>Balance Sheet</u>, our cash in the Checking/Peoples Bank went from \$104,681.87 to \$52,135.73. Decrease of \$52,546.14. Fixed Assets- Vehicles and accumulated depreciation both decreased. This was due to the removal of the old SUV that was traded in and the removal of the accumulated depreciation associated with that SUV.

Statement of <u>Revenue and Expenses</u>- Lodging Tax was not credited to our account at the beginning of the month. Jeff contacted the auditor's office was \$44,166.48 and it was deposited last week. We also received our lodging tax for April room nights in the amount of \$79,338.05. So, I expect the lodging tax that will show in June to total \$123,504.53.

<u>Marketing and Promotion</u> came in at \$8,565.64. \$5,500.00 of this were sponsorships paid on behalf of Cincinnati Alliance Soccer, Spatola Wrestling and Frontier Days. \$2,199.89 were for ads placed with Google, Facebook and Champion Media.

<u>Building Maintenance</u> – Repairs came in at \$1,390. This was paid to D&J Home Improvement, grass cutting and landscaping.

<u>Meetings And Travel</u> came in at \$8,264.23. \$2,664.52 was hotel expense for the Simpleview Conference \$1,223.00 was paid to Delta for Airline tickets to attend SportsETA. The balance is mainly meals & travel associated with the conferences.

For our investments, TD market value ended May at \$50,457.62. EJ market value ended May at \$361,193.86. These were not significant changes from the previous month.
